This intensive five-day programme is designed specifically for international professionals who draft or review contracts in English. It focuses on practical drafting skills rather than legal theory, helping participants draft clear, structured, and commercially effective agreements.

Participants will learn how to avoid common drafting mistakes made by non-native speakers, improve clause structure, use appropriate legal terminology, and draft provisions that are enforceable and commercially sound. Through guided drafting exercises, clause analysis, and structured practice, participants will gain confidence in drafting contracts used in cross-border transactions.

The programme is suitable for lawyers, in-house counsel, contract managers, and commercial professionals who work with English-language contracts in international settings.
